REGULATIONS COVERING THE SALE OF ALCOHOLIC BEVERAGES

- California** - - - Liquor, Wine and Beer sold except on Election Days while polls open. No sales between Midnight and 6:00 a.m. State sales tax applies.
- Colorado** - - - Liquor, Wine and Beer sold except on Election Days while polls open. No sales on Sundays or Christmas before 8:00 a.m. or after 8:00 p.m.
- Idaho** - - - - Liquor, Wine and Beer sold except on Election Days while polls open. Only beer sold on Sundays and on Memorial Day, Thanksgiving and Christmas. State sales tax applies.
- Illinois** - - - - Liquor, Wine and Beer sold except on Election Days while polls open; not until noon on Sundays. State sales tax applies. It is unlawful to accept Credit Cards.
- Iowa** - - - - Beer (of less than 4% alcohol by weight), wine and liquor, except on Sundays and on Election Days while polls open. No sales or consumption of alcoholic beverages between the hours of 1:00 A.M. and 7:00 A.M. on week days and between the hours of 12:00 Midnight on Saturday and 7:00 A.M. on the following Monday.
- Kansas** - - - - No Liquor, Wine or Beer sold.
- Missouri** - - - Liquor, Wine and Beer sold except on Election Days while polls open. No sales on Sundays. State sales tax applies.
- Nebraska** - - - Liquor, Wine and Beer sold except on Election Days while polls open. Only Beer sold on Sundays. State sales tax applies. It is unlawful to accept Credit Cards.
- Nevada** - - - - Liquor, Wine and Beer sold. State sales tax applies.
- Oregon** - - - - Liquor, Wine and Beer sold except on Election Days while polls open. No State sales tax.
- Utah** - - - - Liquor, Wine and Beer sold. State sales tax applies.
- Washington** - Liquor, Wine and Beer sold except on Election Days while polls open. Liquor by the drink Sundays from 2 P.M. until 10 P. M. State sales tax applies.
- Wyoming** - - - Liquor, Wine and Beer sold. State sales tax applies. It is unlawful to accept Credit Cards.
